BOOKINGS - GROUP BOOKINGS

BOOKINGS - PRIVATE LUNCHESES

TO SECURE YOUR BOOKING FOR A PRIVATE EVENT, YOU MUST RETURN A SIGNED CONTRACT AND PAY A \$1000 DEPOSIT.

SUNDAY & PUBLIC HOLIDAY SURCHARGE

SMOKING

NO SMOKING IS PERMITTED DURING OPEN HOURS.

ALCOHOL

ONLY BEVERAGES PROVIDED BY ROZELLE'S MAY BE CONSUMED. BYO IS NOT PERMITTED.

ALCOHOL IS NOT PERMITTED TO BE CONSUMED BY THE CLIENT OR CUSTOMERS OUTSIDE OF THE LICENSED HIRE AREA. ROZELLE'S RESERVES THE RIGHT TO REFUSE SERVICE OF ALCOHOL TO INTOXICATED OR DISORDERLY PATRONS. THESE PATRONS MAY ALSO BE ASKED TO LEAVE THE PREMISES. THROUGH THE LIQUOR LICENSING ACT, WE HAVE A DUTY OF CARE FOR STAFF AND PATRONS AND THEREFORE ACT ACCORDINGLY. WE DO NOT SUPPLY LIQUOR TO PERSONS UNDER 18 YEARS OF AGE. WE RESERVE THE RIGHT TO REQUEST SUITABLE IDENTIFICATION. ANY ADULT SUPPLYING ALCOHOL TO A MINOR WILL BE REMOVED.

DECORATIONS AND DAMAGES

CANDLES OR OPEN FLAMES ARE STRICTLY PROHIBITED IN THE GARDENS. ONLY SMALL GLASS VOTIVE CANDLES ARE PERMITTED IN ROZELLE'S. CONFETTI OR CONFETTI-LIKE MATERIALS ARE NOT PERMITTED. NO ITEMS MAY BE NAILED, AFFIXED, HUNG, OR ADHERED TO ANY WALLS, WINDOWS, CEILINGS, FIXTURES, OR SURFACES, INCLUDING THE USE OF BLU TACK, TAPE, 3M OR ADHESIVE HOOKS, OR ITEMS SUSPENDED FROM THE CEILING. ALL DECORATIONS MUST BE DELIVERED, INSTALLED, AND REMOVED STRICTLY WITHIN THE BOOKED EVENT TIME. NO ITEMS MAY BE DELIVERED BEFORE OR STORED AFTER THE EVENT. ALL DECORATIVE ITEMS MUST BE REMOVED IMMEDIATELY AT THE CONCLUSION OF THE BOOKING. YOU AND YOUR GUESTS ARE FULLY FINANCIALLY RESPONSIBLE FOR ANY DAMAGE OR EXCESSIVE CLEANING REQUIRED, WHETHER ACCIDENTAL OR OTHERWISE. THIS INCLUDES DAMAGE TO BUILDINGS, FIXTURES, WALLS, WINDOWS, FLOORING, CARPETS, GARDENS, AND GROUNDS. COSTS FOR REPAIR, CLEANING, OR REPLACEMENT WILL BE CHARGED ACCORDINGLY.

FALSE ALARM FEE

EXTREME EMERGENCIES & CATASTROPHIC FIRE DAYS CARRICK HILL IS LOCATED IN A BUSHFIRE-PRONE AREA AND MAY BE IMPACTED BY CATASTROPHIC FIRE DAYS OR OTHER EXTREME EMERGENCY EVENTS. EVERY REASONABLE EFFORT WILL BE MADE TO KEEP THE PROPERTY OPEN AND PROCEED WITH BOOKED FUNCTIONS WHILE PRIORITISING SAFETY.

IF, DUE TO AN EXTREME EMERGENCY OR CATASTROPHIC FIRE DAY, IT IS DEEMED UNSAFE OR CARRICK HILL IS REQUIRED TO CLOSE, CARRICK HILL / ROZELLE'S RESERVES THE RIGHT TO CANCEL THE EVENT. NOTICE OF CANCELLATION WILL BE PROVIDED AS SOON AS PRACTICABLE. IN THE EVENT OF CANCELLATION, ANY MONIES PAID WILL BE REFUNDED OR ALTERNATIVE DATES OFFERED TO RESCHEDULE THE EVENT.
